### Instructions and notes for electronic participation at the 2022 Annual General Meeting

Shareholders or their duly appointed proxies or representatives who wish to participate in the Annual General Meeting (AGM) via a remote interactive electronic platform, must **register** to do so by lodging their Electronic Participation Registration Form with the company secretary **by emailing** it, together with proof of identity of the participant, to the company secretary at [companysecretary@businesspartners.co.za](mailto:companysecretary@businesspartners.co.za) by **10h30 on 15 August 2022**. The company secretary will verify each applicant's entitlement to participate in and vote at the AGM. By close of business on 15 August 2022, the company secretary will forward to each electronic participant an electronic meeting invitation with a link to enable participants to link up and participate electronically in the AGM.

Applications for registrations for participation in the AGM by electronic means, will only be considered if this registration form is completed in full, signed by the shareholder, its proxy or representative, and delivered as detailed above. The Company may in its sole discretion accept any incomplete application forms. Participants will be responsible for their own network arrangements and charges for electronic participation in and voting at the AGM. Any such charges will not be for the account of the Company and the Company will not be held accountable in the case of loss or interruption of network connectivity or other network failure for any reason whatsoever which prevents any participant from participating in and/or voting at the AGM. The participant holds the Company harmless against any loss, injury, damage, penalty or claim arising in any way from the use of the telecommunication lines to participate in the AGM or any interruption in the ability of the participant to participate via electronic communication, whether or not the problem was caused by any act or omission on the part of the participant or anyone else, including without limitation the Company and its employees.
